CONTAINER FREIGHT STATION SERVICES CONTRACT

TO: IMPERIAL CFS, INC.

The undersigned, ("Proprietor/Authorized Agent"), does retain Imperial CFS, Inc.("Imperial") to provide container freight station services to the Proprietor at the Proprietor's request, and with Proprietor's knowledge and assent at Imperial's place of business which is located at 1000 Francisco St. Torrance Ca. 90502.

In consideration for Imperial agreeing to provide container freight station services to the Proprietor, the Proprietor agrees to pay Imperial all amounts which are invoiced by Imperial. Each such invoice which is mailed, or otherwise delivered to the Proprietor by Imperial, shall be paid by Proprietor within 07 days of the mailing of the invoice, or the delivery date of the invoice, whichever occurs first. Time shall be of the essence with respect to the payment of each invoice presented to the Proprietor for container freight station services provided by Imperial so that each invoice must be paid within 07 days (whichever occurs first) the mailing of the invoice or the delivery of the invoice to the Proprietor.

It is further agreed and understood by the Proprietor that the failure to pay Imperial within the specified terms, as set forth above, any invoice which is sent by IMPERIAL CFS, INC. to the proprietor shall be deemed a breach of this contract.

It is further agreed and understood by the Proprietor that should suit be brought to enforce or defend this contract or any portion thereof, the prevailing party shall be entitled to reasonable attorney's fees and costs in addition to any other damages allowed.

It is further agreed and understood by the Proprietor that the place of performance of this contract shall be Imperial's place of business which is located at 1000 Francisco St. Torrance, Ca. 90502.

The parties to this contract warrant that they have each read this contract, have had time to consider it and have obtained the advice of their attorney's regarding this contract, its meaning and application, and are signing of their free will with the intent of being bound by it.

This contract shall be governed by the substantive and procedural laws of the State of California and shall be binding upon the parties, their officers, directors, partners, employees, agents, representatives, affiliates and successors in interest.

This contract may not be modified except in writing signed by the parties or their authorized representative and is binding on the parties as of the date hereof.

This contract constitutes the entire agreement of the parties regarding the services to be provided to the Proprietor. No representation or warranties or promise have been made by any party other than those
